## **TERMS & CONDITIONS**

- BUYER agrees that he/she understands how to care for and maintain the health of the Boerboel breed as well as sufficient knowledge of breeding and its effect on the health of a Boerboel.
   Health issues to be aware of include: skin allergies, hip and/or elbow dysplasia, eye conditions, etc.
- BUYER agrees that male boerboel can be used for breeding within buyers personal program but will NOT be used as an outside stud. In certain circumstances arrangements may be made with Outlaw Boerboels for exceptions.
- SELLER agrees that full registration (full breeding rights) is granted with the purchase of the male
  or female boerboel pup should the buyer decide to breed in the future and SELLER
  professionally recommends that the boerboel is fully health tested before breeding.
- BUYER agrees and understands that he/she is solely responsible for the Boerboel puppy and releases Outlaw Boerboels from any and all liability resulting from the Boerboel puppy's behavior when ownership changes from SELLER to BUYER.
- BUYER agrees that Outlaw Boerboels will not be financially responsible for any medical procedures or treatments for the Boerboel puppy on or after the purchase agreement date stated.
- BUYER agrees to provide sufficient food, water, shelter, and attention.
- BUYER agrees and understands that the Boerboel is to be feed no more than 26% protein after
   12 weeks of age, unless explicitly advised or prescribed by a veterinarian. \*
- \*Documentation of dog food purchases are needed if the buyer is requesting a refund or replacement Boerboel.
- BUYER agrees that this Boerboel will not be involved in dog fighting or any animal baiting sports.
   If this Boerboel is identified in dog fighting or any animal baiting sports, the buyer agrees to surrender this Boerboel to Outlaw Boerboels or authorized person acting on behalf on Outlaw Boerboels.
- BUYER agrees SELLER will repossess dog or bitch upon evidence of neglect and/or abuse at no expense to the seller.
- BUYER understands that the Boerboel is a large, dominant breed and is not for everyone. It is the buyer's responsibility to provide proper socialization and training for the dog. Outlaw Boerboels accepts no liability for temperament problems that may occur.
- BUYER agrees that the Boerboel is not to be left in a crate or kennel only. Under no
  circumstance shall this dog be left chained. This puppy is sold with the understanding that it is
  to go to carefully selected parties willing to raise the puppy as a member of the family as to
  assure proper development and maintenance of the temperament for which the animal was
  bred.
- BUYER agrees to allow, at SELLER's expense, two semen collection once puppy is of age, if requested by the SELLER. BUYER agrees to communicate and accommodate to the best of their ability, to fulfill semen collection transfer to SELLER.
- All Outlaw puppies are required to carry the Outlaw name on their SABBS/AKC/NABBA or any other Boerboel breed registration papers.

## **HEALTH GUARANTEE**

- You must take your puppy to a licensed veterinarian or minimally have an appointment scheduled for a general health check-up within 3 business days from the date of possession. Failure to do so will result in all guarantees to be null and void.
- Puppy must remain current on all vaccinations and de-worming.
- If a serious health problem occurs, written documentation must be provided from your licensed veterinarian and submitted to Outlaw Boerboels for review within one week of time that puppy was seen and diagnosed. The Dog/Bitch must not have been bred. The breeding of said dog listed in this contract voids all warranties. Upon review and acceptance of said issue, we will replace the puppy with the next available puppy. The defective puppy must be spayed or neutered with proof provided to Outlaw Boerboels.
- Replacements are made when pups are available. There is no guarantee as to the time frame of the replacement. When replacements are made, the buyer is responsible for all shipping costs. Guarantees are extended to the original purchaser only and are nontransferrable.
- Outlaw Boerboel puppies come with a 24-month guarantee against crippling/severe hip or elbow dysplasia. This must be certified by the Orthopedic Foundation for Animals (OFA). Reckless handling, severe accidents, trauma, over-feeding, over-exercising must not be in question and must be documented on the vet report of said puppy's overall condition.
- Boerboel puppies often have umbilical hernias shortly after birth from the mother pulling too tightly or in some cases may be hereditary. These are not covered in the health guarantee or discounted. These most likely will go away on their own, however, you can assist the process by rubbing the bellybutton and pushing it back in with a circular motion.
- Entropion/Ectropion (eyelids rolling in or out) are also common issues in the Mastiff breed and not covered by the health guarantee.
- In the event that buyer does not adhere to the requirements all guarantees are void. The buyer will notify the breeder first if for any reason the buyer no longer wants to or is unable to keep the puppy/dog. The breeder shall have first right of refusal if the puppy/dog is to be sold or disposed of in any way. If the breeder does not want to acquire the dog, the breeder will assist in placing the puppy/dog in a new home if the buyer so chooses. The buyer will notify the breeder of any changes of address and will maintain contact with the breeder throughout the life of this dog.
- The guaranteed portion within the contract is null and void if the dog has been physically altered in any way.
- (i.e., ears cropped, spayed, neutered, etc.)

## RIGHT OF RECOVERY OR REPLACEMENT

Should the BUYER decide not to keep the dog, the BUYER agrees that the SELLER will be contacted first and given first rights to the dog. SELLER will be given first right of refusal. If first right of refusal is bypassed, BUYER agrees to pay fee of \$2500 to SELLER.

BUYER agrees that the Boerboel puppy will NOT under any circumstance be placed in a dog pound or rescue center.

By signing and initialing this document, BUYER agrees that he/she understands this contract fully and understands that this contract is a legally binding agreement between BUYER and SELLER. It is agreed upon that in the unlikely event of legal matters pertaining to this dog and/or any breach of this contract, all jurisdictions will take place in Franklin County, Washington. BUYER will be responsible for all costs associated with litigation due to the breach of this contract.
